Army Travel Campground Rules and Fees effective April 1, 2010

Thank for choosing the Family Morale, Welfare, and Recreation (FMWR) Army Travel Campground at Smith Lake Recreation Area as your preferred choice of destination. We are excited to welcome you as our guest and hope you enjoy your stay with us.

1. Patron Eligibility IAW AR 215-1, Ch 7-1

Active duty (AD) military personnel, ready reserve members, retired military personnel, eligible family members, US DOD APF/NAF civilians and DOD contract personnel. Guests and minors must be accompanied by authorized patrons.

2. Length of Stay

a. IAW AR 215-1 Ch 8-25 d (2) Homesteading is strictly prohibited, extended stay is limited.

3. Campground Fees per day, Vehicle passes must be visibly displayed at all times (Prices subject to change)

- Full Service RV pull-thru site (water, electric and sewer) ----- \$20.00 one RV/Camper / 2 POVs
(First come, first serve, not to exceed 2 weeks)
- Full Service RV back-in site (water, electric and sewer) ----- \$18.00 one RV/Camper / 2 POVs
- Monthly Fee ----- \$450.00
- Partial Service RV and Camp site (water/electric) ----- \$15.00 one RV/Camper / 2 POVs
- Monthly Fee ----- \$390.00

America the Beautiful card holders receive a \$2.00 discount off of daily RV site rates

- Primitive Tent camping ----- \$8.00 per tent / 2 POVs
- Partial Service Tent camping (water/electric) ----- \$15.00 per tent / 2 POVs
- Primitive Log Cabins (max. occupation 4) ----- \$35.00 per night / 2 POVs
Table w/ 4 chairs, AC/Heater unit, microwave and fridge
1 double bed, 1 set of bunk beds (rated for kids only), must bring own sheets, blankets, pillows & towels
- Full Service Log Cabins (max. occupation 8) ----- \$85.00 per night / 4 POVs
Table w/ 4 chairs, AC/Heater unit, kitchenette and bathroom / shower,
2 double beds, 1 set of bunk beds (rated for kids only), 2 full-sized futons, bring your own sheets, blankets, pillows & towels
- Additional Vehicles (Patrons and Visitors) ----- \$ 2.00 per day

4. Guests and Social Events

- Guests must pay additional vehicle fee and visibly display a guest pass in the vehicle. Guests must leave the campground before quite time at 11pm. Overnight stays are not permitted.
- The camp ground is for the recreational use of registered patrons. Social events and group entertaining must be coordinated and approved. An additional fee in the amount of \$50.00 per day applies, not to exceed a party of 25.

5. Facility Information

- Campground is open Year Round, Smith Lake Recreation Area is patrolled by Fort Bragg Military Police
- Check-in 3pm, Check-out 12pm, early check-in and late-check out may be available for a ½ day's additional rental fee
- Office hours, daily 8am – 5pm (late arrivals must call for check-in instructions prior to closing time)
- Quiet hours 11pm to 8am, however, disturbances will not be tolerated at any time
- SPEED LIMIT is 10 mph . Traffic throughout the campground is One-Way.

6. Reservation/Cancellation

- Reservations are accepted 90days in advance.
- To guarantee a reservation, a one night's rental fee is required for each site, VISA/MC , Cash and Checks are accepted. We accept reservations by phone or in person. Full refunds will be processed if reservation is cancelled 14 days prior to arrival date.

7. Pets (certain breed restrictions apply)

- Pets are permitted on RV and Tent sites only. Pets must be on the leash at all times and not left alone.
- Pets are not permitted in or around the cabins and bath houses and in the Park/Picnic area.

8. Smoking / Open Fire / ATV - Off-Road / Firearms / Fireworks

- **Smoking is not permitted in or around the cabins and bath houses**
- Open fires are not permitted, please use fire rings. Use of wood on the ground is permitted, do not cut or disturb trees or other plantings. Don't put trash in fire rings or burn trash in the fire rings.
- ATV and Off-Road riding is prohibited on Ft. Bragg
- Firearms and Fireworks are prohibited

9. Amenities

- 2 bathhouses on campground premises
- Dump Station complimentary for camp ground patrons
- Complimentary lake bank fishing (Ft. Bragg and NC State license is required)
- Complimentary access to the beach during posted beach opening hours for registered campground patrons
- Complimentary ice
- Coin operated washer/dryer at office
- Walking and Mountain Bike Trails, Mountain bike rentals
- Riding Stables and Paintball operation
- Recycle bins in campground bath house
